

ORDINANCE TO AUTHORIZE THE MAYOR TO PURCHASE ONE 2015 FORD F-550 TRUCK AND RELATED EQUIPMENT FOR THE STREET DEPARTMENT AND DECLARING AN EMERGENCY.

**Whereas**, the Street department is in need of a truck with plow and related equipment for efficient operation of its department; and

**Whereas**, the funds have been appropriated for this purchase and are available in account number 260.268.5632; and

**Whereas**, the truck that will be replaced will be transferred to the Parks & Recreation Department; and

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF REYNOLDSBURG, OHIO:**

**SECTION 1.** That the Mayor be and is hereby authorized and directed to purchase from Byers Ford, 1101 Columbus Pike, Delaware, OH 43015 one 2015 Ford F-550 and related equipment for a total purchase price \$41,426.00.

**SECTION 2.** That the Mayor be and is hereby authorized and directed to purchase from Kaffenbarger Truck Equipment Company, 2265 Refugee Road, Columbus Ohio 43207 one snow plow for a total purchase price \$6,195.00.


**SECTION 3.** That the Mayor be and is hereby authorized and directed to purchase from Pengwyn, 250 West Fifth Avenue, Columbus, Ohio 43204-3815 one hydraulic system, bed and spreader for a total purchase price \$27,165.00.

**SECTION 4.** That pursuant to CRC Section 8.04( c), the purchase shall be made through the City of Columbus Contract SA#004728 Light Duty Trucks and competitive bidding is hereby waived.

**SECTION 5.** That this ordinance is deemed to be an emergency measure necessary for the financial needs of the city, and further to maximize the use of city resources by obtaining optimal products at low prices and replace older, high-maintenance units used in the daily operations of the Street Department; wherefore upon adoption by Council this ordinance shall be in effect immediately upon signature by the Mayor.
