

ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF REYNOLDSBURG, OHIO: SECTION 160.02 "AUTHORIZED POSITIONS, PERSONNEL, CLASSIFICATION AND PAY GRADE" Subsection (g) "Service Department", Subsection (3) "Water/Wastewater Division"; of CHAPTER 160 EMPLOYEE COMPENSATION, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF REYNOLDSBURG, OHIO:

SECTION 1. That Section 160.02 "Authorized Positions, Personnel, Classification and Pay Grade" Subsections (g) "Service Department", Subsection (3) "Water/Wastewater Division" of Chapter 160 Employee Compensation of the Code of Ordinances of the City of Reynoldsburg shall be and are hereby amended to read as follows:

SECTION 2. That existing Subsection 160.02 (g)(3) be and is hereby repealed and replaced.

SECTION 3. That this ordinance is deemed to be an emergency measure necessary for the financial needs of the city and further to coincide with the contract for meter reading; wherefore upon adoption by Council this ordinance shall be in effect immediately upon signature by the Mayor.
